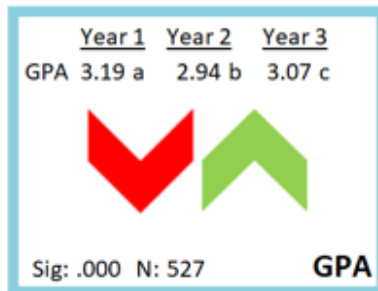


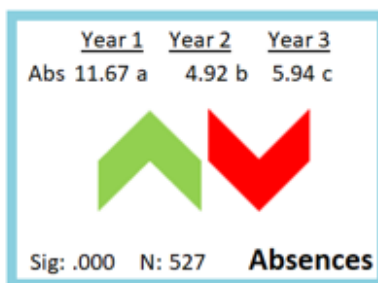

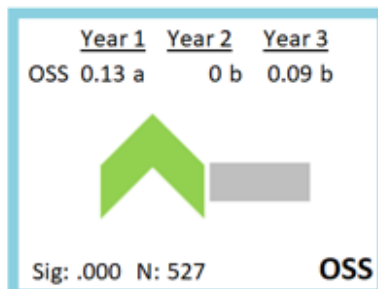
3-Year Summary Report (2014-2017)
